



## Legal notice – Image, text, and film content

1. The company RUAG Ammotec GmbH (hereinafter “RUAG Ammotec”) provides its authorized specialist retailers (“Users”; “User” in the singular) information in the form of images and text (“Content”) where necessary and upon request for the advertising of products. “Use” is to be understood as utilization in one’s own interest, printed, electronic, or other form of reproduction, and dissemination, in particular making accessible both publicly and privately, both via print and electronic media, as well as online on the Internet.
2. The User is to use the Content exclusively in the manner described under point 1. Use on the online platform “eBay” or on similar online platforms is not permitted. Any other use by the User requires prior written consent (including via fax or electronic means) by RUAG Ammotec.
3. The User shall undertake to use the Content in a manner such that, to their knowledge, no third-party rights are infringed upon. The User shall indemnify RUAG Ammotec against all third-party claims which are made against RUAG Ammotec due to the use of the Content by the User in a manner that is in violation of contract.
4. The Content is to be used exclusively in the form provided by RUAG Ammotec. Modification or editing of the Content is not permitted.
5. When using the Content, the User shall undertake to include a notice in direct spatial proximity and in a suitable manner indicating that it was provided by RUAG Ammotec.
6. The Content shall not be handed over to third parties.
7. Use of the Content for purposes not covered in point 1 is only permitted with prior written consent from RUAG Ammotec.
8. The right to use the Content as specified in point 1 begins with the provision by RUAG Ammotec.
9. The right of use as specified in point 1 ends automatically at the point in time at which the User loses the status of authorized dealer due to any reason.
10. The Content provided remains the property of RUAG Ammotec.
11. The User shall have no right of retention to the Content.
12. RUAG Ammotec shall be within its rights to revoke the User’s right to use the Content for cause. In particular, cause is given when there exists reasonable suspicion that the Content is being used in violation of these terms of use or if the rights of RUAG Ammotec or third parties are infringed upon. Points 10 and 11 apply accordingly. Furthermore, in such cases the User shall undertake to immediately discontinue its own utilization of the Content upon receiving a written request by RUAG Ammotec, to cease making the Content available, including any copies, to take publications in which the Content is utilized out of circulation, and to remove the corresponding web presences from the Internet.
13. The User is aware that the Content is provided in the form that is available to RUAG Ammotec. RUAG Ammotec makes no guarantee whatsoever that the Content is suitable for use by the User nor that it exhibits any particular characteristics. RUAG Ammotec shall not be held liable for damages resulting from the use of the Content. RUAG Ammotec shall accept no liability for the content of information which is made available by third parties.
